- 1.1.** These Terms and Conditions, along with our General Website Terms which are available at www.girlabout.co.uk apply to all online events, workshops, demonstrations, activities or other interactive services ("**Events**") that are provided by or facilitated by All About The Story Limited trading as Girl About and the Girl About Travel Club ("**we**" "**us**", "**our**"). We are registered in England and Wales under company number with company number 10027642 and registered office at 9 Barrowby Close, Menston, Ilkley, West Yorkshire, England, LS29 6EA and our contact email address is support@girlabout.co.uk ("**We**", "**us**").
1. By completing the Event booking form you are agreeing to these Terms and Conditions which incorporate our General Website Terms ("**Terms**"). Our legal binding agreement is formed when we send your Event booking confirmation email.
 2. All Events are subject to availability.
 3. The Fee for the Event is as set out on the booking form at the time of completion and is inclusive of VAT. Payment must be made in GBP, in full, at the time of completing the booking form. Where payment is not made at the time of booking it must be provided within 7 days otherwise your booking will be cancelled.
 4. No refunds will be provided, except where we choose to cancel the Event. If we do cancel the Event we shall use our reasonable endeavours to provide a refund within 30 days.
 5. Should we need to make changes to an Event or reschedule then we shall, where practicable, provide you with reasonable notice and shall provide at least 14 days' notice of any rescheduled date. No refund shall apply if you are unable to attend the rescheduled date.
 6. Your Event booking is personal to you and should not be shared, disclosed, assigned, sold or transferred in any way.
 7. We shall communicate with you using the details you provide on the booking form. If your details change you must contact us to update your details.
 8. By completing the booking form, you accept and acknowledge that your viewing, participation, use of, access to and engagement with any Event shall be at your own risk and we shall have no liability to you whatsoever in connection with the provision of any Event. You shall be personally responsible for reviewing the content and details of any Event and for deciding whether the Event is suitable for you to attend, view or engage with. Where you choose to participate in any Event and/or any activities offered or provided as part of an Event, then such decision shall be wholly at your own risk and you will remain responsible for your own health and safety at all times.
 9. We shall not be liable for any loss or damage suffered by you whatsoever in relation to any Event, save that we shall not exclude or limit our liability for death or personal injury due to our negligence or for fraudulent misrepresentation.
 10. Our total liability to you shall be limited to the price paid by you for the Event ticket.
